a. AUD222RB1 – Accept 2020 403B Audit Report and IRS Form 5500	Martha Parker, Engagement Partner at ELC's Audit Firm Keefe McCullough, presented the results of ELC's first 403B plan retirement audit and IRS form 5500 for the plan year ending December 31, 2020.		
	There were no findings. However, Ms. Parker noted that Administration of ELC's Plan has become too complex to be handled in-house by staff now that ELC has grown much larger, and recommended that the Committee consider hiring a qualified Third Party Administrator to oversee plan administration going forward.		
	A Motion was made by Monica King to approve the Audit Report & Management Response for 403B Retirement Plan Year 2020, and IRS Form 5500 for 403B Retirement Plan Year 2020. Seconded by Michael Asseff. Unanimously Approved. Motion Passes. Staff informed the committee of a recently discovered systemic problem in the ADP Payroll system that caused problems with some payroll calculations. Staff intend to correct the issue on a go-forward basis.		
	Martha Parker noted that Christine and her team found and reported this issue on their own. It shows that our internal controls are working and that the team making the effort

### **Background Information:**

In accordance with the Early Learning Coalition's fiscal policies and the OEL Grant Agreement, an audit of the Coalition's financial operations is performed annually. For FY 2021, ELC's external audit firm, Keefe McCullough, began a virtual site visit in October 2021 and completed a Draft Audit Report and Draft Form 990 on February 1, 2022.

### **Current Status:**

Keefe McCullough will present their results at the meeting:

- The Preliminary Draft Audit Report contains no findings.
- IRS Form 990 was prepared by Keefe McCullough's tax team. It reflects financial data tested during the FY21 audit process and has been reviewed and reconciled by staff to the financials.
