School Readiness (SR) Enrollment Update

After initially pausing enrollment at the start of the fiscal year due to a budget reduction, staff began enrolling again from the School Readiness waitlist on October 8th. Since then, we have been pulling approximately 800 children off the SR waitlist every three weeks. We currently have approximately 14,125 children enrolled, and as of February 4th, our waitlist is 1,189. Our wait time from application to actual enrollment is approximately 8 weeks.

VPK Enrollment Update

As of February 4th, we have 11,655 children enrolled in VPK. At this time last year, we had approximately 900 more children enrolled. However, this decreased amount tracks with the VPK Estimating Conference's decreased number of Broward children enrolling in VPK. The Estimating Conference's school year estimate for the 2025-26 school year is 11,782. We'll keep the board updated concerning enrollment throughout the rest of the school year.

Some potential good news, on the first day for parents to submit VPK applications for the 2026-27 school year, we received over 1,000 applications. We normally receive only approximately 500 applications on the first day. While this is no guarantee we'll see larger actual enrollment numbers at the start of the next school year, this initial application number is encouraging.

Legislative Update

For the FY 26 Legislative session, ELC Broward's legislative priority is focused on School Readiness funding stability. While we continue to push for increased investment in the program statewide and specifically in Broward, based on the current climate, we are also realistically pushing for at least flat funding. Renee Jaffe, CEO, presented this priority at the Broward Legislative Delegation's Public Hearing on November 13th.

Statewide, the Governor's Budget recommendations (as well as DEL's) keep all SR funding intact with a \$10 million increase in match funding. Proposed House and Senate SR budget and Coalition allocations have yet to be released.

Locally, staff efforts to raise awareness for School Readiness (SR) programs are yielding significant returns. A November presentation to the Northwest Council of elected officials generated immediate requests for ELC commission presentations. Most notably, following our December 16 presentation detailing SR impacts to the City of North Lauderdale, their Commission requested a 50% increase in their municipal match contribution. This increase was officially approved on January 13, 2026, demonstrating the tangible value of these educational outreach efforts.

Early Learning Landscape Analysis

The ELC's funding proposal to the Broward Workshop for the Early Learning Landscape Analysis research project was officially approved at the end of 2025, and we continue to finalize plan details. While we had hoped to have launched this project by now, due to staffing changes at the Florida Chamber Foundation, the collaborative work between our organizations has been on hold. While the exact launch of the surveys and focus groups remains TBD, we recently received good news the Florida Chamber will resume working with us in late February.

As a reminder, this project is a collaboration between the Florida Chamber Foundation and ELC Broward to better understand the early learning landscape in Broward. The study is funded by The Broward Workshop, individual Broward Workshop members, and other funders like the CSC, and the Community Foundation of Broward, and will be used to drive the creation of a future early learning Broward roadmap. The project will include surveys and focus groups with early learning stakeholders and partners, including parents, childcare owners/directors, early educators, private employers, and the Broward school district parents as well as ELC internal data, additional data, including but not limited to ALICE populations, housing, population trends, socioeconomic status, demographics, and the Chamber Foundation's score card and Gap Map, etc. This data will be analyzed and included in a comprehensive report giving insight to the state of childcare in Broward as well as challenges, successful practices, and an early learning road map for the future.

Repeal of CCDF Childcare Rules

The U.S. Department of Health and Human Services (HHS), through its Administration for Children and Families, the federal arm overseeing the nationwide childcare subsidy program, announced its plans to rescind a series of childcare rules approved in 2024 that were put in place to better support the childcare provider community and low-income parents. These provisions were scheduled to be implemented in August 2026 and included reimbursing childcare programs based on enrollment rather than attendance, paying childcare providers in advance of services, and allowing for guaranteed provider reimbursements for a set number of contracted slots for hard-to-serve populations (infant/toddler care, special needs).

Rollout of ELC's New Payroll System

On January 7, 2026, we successfully completed our first payroll using the Coalition's new human resources and payroll system, UKG. Over the past five months, the HR, Finance, and IT teams have collaborated to design and implement streamlined workflows that enhance efficiency and provide better access to key data across the organization. This was a huge effort that required a lot of teamwork and time. It rolled out without any major issues.

A person holding elective or appointive county, municipal, or other local public office MUST ABSTAIN from voting on a measure which inures to his or her special private gain or loss. Each elected or appointed local officer also is prohibited from knowingly voting on a measure which inures to the special gain or loss of a principal (other than a government agency) by whom he or she is retained (including the parent organization or subsidiary of a corporate principal by which he or she is retained); to the special private gain or loss of a relative; or to the special private gain or loss of a business associate. Commissioners of community redevelopment agencies under Sec. 163.356 or 163.357, F.S., and officers of independent special tax districts elected on a one-acre, one-vote basis are not prohibited from voting in that capacity.

Background Information:

On September 15, 2025, the Department of the Treasury and the Internal Revenue Service (IRS) issued final regulations addressing several SECURE Act 2.0 provisions relating to catch-up contributions. Catch-up contributions are additional contributions under a 401(k) or similar workplace retirement plan for employees who are age 50 or older. The final regulations require that catch-up contributions made by participants with FICA wages that exceeded \$145,000 in the prior year must be designated as after-tax Roth contributions starting January 1, 2026. Our Plan does not currently allow employee deferrals to Roth accounts at all, and the Plan must be amended to make this option available to all participants, including those affected by the new rule, so that everyone over age 50 has the opportunity to maximize their retirement savings through our Plan.

The final regulations also provide guidance relating to increased catch-up contribution limits under the SECURE Act 2.0 for plan participants between the ages of 60-63. Since these “super catch-up” contributions are not mandatory for all plans, the IRS recommends that a plan's terms clarify whether or not a reference to the age 50 catch-up contribution limits in the plan terms includes the optional higher limit for participants attaining age 60, 61, 62, or 63. The plan must therefore be further amended to affirm that this option will be permitted effective January 1, 2026.

Corebridge Financial, the record-keeper and platform for our Plan, will eventually issue an updated prototype plan document that will incorporate all of the requirements from the final regulations by the IRS deadline in 2027, but we wish to adopt amendments to the current Plan documents now to ensure that the Plan is being operated in accordance with its written terms in the meantime.

Current Status:

Staff have worked with Corebridge to draft two amendments to the Plan: The first amendment permits Roth employee deferrals for all participants; and the second affirms that age 50 catch up contributions allowed by the Plan include the optional higher limit for participants attaining age 60, 61, 62 or 63 during the Plan year.

Corebridge requires that the two changes be memorialized in two different amendments. Drafts of the amendments are attached and are pending legal review.

AMENDMENT TO THE EARLY LEARNING COALITION OF BROWARD COUNTY, INC. RETIREMENT PLAN (“the Plan”) [PERMITTING ROTH DEFERRALS]

WHEREAS, Early Learning Coalition of Broward County, Inc. (the “Employer”) maintains the Early Learning Coalition of Broward County, Inc. Retirement Plan (the “Plan”) for its employees;

WHEREAS, Early Learning Coalition of Broward County, Inc. has decided that it is in its best interest to amend the Plan;

WHEREAS, Section 14.01(b) of the Plan authorizes the Employer to amend the selections under the Early Learning Coalition of Broward County, Inc. Retirement Plan Adoption Agreement.

NOW THEREFORE BE IT RESOLVED, that the Early Learning Coalition of Broward County, Inc. Retirement Plan Adoption Agreement is amended as follows. The amendment of the Plan is effective as of 1-1-2026.

1. The Adoption Agreement is amended to read:

6A-5 **ROTH DEFERRALS.** Roth Deferrals (as defined in Section 3.03(g) of the Plan) are not permitted under the Plan, unless designated otherwise under this AA §6A-5. Roth Deferrals, if available, are subject to the terms of the governing Investment Arrangement(s).

- (a) **Availability of Roth Deferrals.** Roth Deferrals are permitted under the Plan. [*Note: If Roth Deferrals are effective as of a date later than the Effective Date of the Plan, designate such special Effective Date in AA §6A-9 below.*]
- (b) **Distribution of Roth Deferrals.** Unless designated otherwise under this subsection, to the extent a Participant takes a distribution or withdrawal from his/her Salary Deferral Account(s), the Participant may designate the extent to which such distribution is taken from the Pre-Tax Deferral Account or from the Roth Deferral Account. (See Section 8.10 of the Plan for default distribution rules if a Participant fails to designate the appropriate Account for corrective distributions from the Plan.)

Alternatively, the Employer may designate the order of distributions for the distribution types listed below or in a separate administrative procedure:

- (1) **Distributions and withdrawals.**
 - (i) Any distribution will be taken on a pro rata basis from the Participant’s Pre-Tax Deferral Account and Roth Deferral Account.

Background Information:

In 2022, the Early Learning Coalition (ELC) selected Goren, Chero, Doody & Ezrol, P.A. (Goren Chero) to provide General Counsel legal services through a public procurement process. Legal services are exempt from the competitive-solicitation requirements of §287.057(3)(e)4, F.S. and the Coalition may choose whether to procure these services at its discretion.

In 2023, the Board approved Goren Chero's recommendation to separately engage Bryant Miller Olive, P.A. (Bryant Miller) to provide specialized labor-related legal services. These services had previously been included within the overall General Counsel scope of work. Both firms operate at the same hourly rates established under the Goren Chero Agreement, and they coordinate on labor-related matters without duplicative effort or billing.

The final contract renewal period for both Agreements expires June 30, 2026. A new legal services contract cycle must therefore begin July 1, 2026, to maintain continuity of legal services and ensure ongoing support for the Coalition's governance, operations, and risk management. Historically, ELC staff have engaged outside counsel Bob de la Fuente, P.A., General Counsel for the Early Learning Coalition of Miami-Dade & Monroe Counties and Shareholder at Lehtinen, Schultz, PLLC, to assist with the development and review of Broward's General Counsel Agreements for a nominal fee.

Current Status:

Both Goren Chero and Bryant Miller have submitted written proposals requesting a rate adjustment from \$250/hour to \$275/hour beginning July 1, 2026, with a 2% annual increase for each subsequent year over a five-year contract period. Staff have reviewed these requests and confirmed that the proposed rates remain highly competitive within the Broward legal services marketplace for comparable work.

Staff report satisfaction with the quality of services provided by both firms and note that the dual-firm structure has functioned effectively throughout the current contract cycle.

Executive Committee Recommendation:

Authorize Coalition staff to forgo competitive procurement and negotiate new contract cycles with Goren, Chero, Doody & Ezrol PA and Bryant Miller Olive PA for legal services starting July 1, 2026, in accordance with the proposed rated changes and pending legal review by outside counsel.

It has been our honor to provide legal services to the Early Learning Coalition of Broward County, Inc. (ELC) for the past five years and we look forward to continuing our relationship with the organization. I have been requested to provide a fee proposal for continuation of our services with the ELC for the next five years.

Our law firm has traditionally charged reduced rates to certain clients, such as the ELC, in consideration of its non-profit status and focus on community services. We intend to continue to do so. Although we have kept our rates flat for this five-year period, costs and rates in the marketplace continue to increase and our rates for the ELC remain disproportionately.

We respectfully submit a proposed increase of our hourly rate from \$250/hour to \$275/hour for the first year of our renewed contract with the ELC. This increase is an amount less than if our rates increased annually by three percent (3%) over the five-year term of our existing contract. In order to avoid large increases in any given year going forward, we further propose a two percent (2%) increase each year in years 2-5. These proposed modifications still fall below professional industry standards in the South Florida marketplace.

Background Information:

The Interim Financial Statements for the six-month period ending December 30, 2025, are attached for review. Financial Highlights for the period are as follows:

- **School Readiness:** FY2026 School Readiness child care slot expenditures (including SR and local funding) were 48% of the annual budget for that line item at the end of the second quarter. This is 2% below the 50% target for mid-year because of enrollment pause during the first quarter and a slightly lower actual average cost of care (.5%) than originally forecast. We anticipate that expenditures will continue to gain momentum over the next two quarters as we call more than 700 children from the waiting list every 3 weeks. The waiting list was 3,243 on September 30, but it has since decreased to approximately 2,100 after we began enrolling again during October. Waiting time for most families on the list was approximately 120 days. We project our average census over the year will be approximately 14,500 children per month. See attached charts for more information and utilization projections going forward.
- Expenditures for Gold Seal and CLASS rate differentials were still high at 57% of their combined allocations, a pace that may again require us to absorb costs due to an anticipated statewide funding shortfall. DEL has indicated that we may receive an additional \$1.5 million in SR base allocation to help cover this shortfall. The request is currently under review with FDOE and we anticipate final confirmation in February.



1. **VPK:** VPK expenditures were 44% as of September, which is lower than the prior year due to a decrease in the population of 4-year-olds in the County. Attendance for school year services began in August and expenditures fluctuate throughout the year. Funding is allocated by DEL to match the actual need for services each year and our allocation will likely be reduced by approximately \$1 million before year end.
2. **Vulnerable Populations Program:** Mid-year expenditures at 65% are high for the Vulnerable Populations Program because program growth has been steadily outpacing its funding allocation for the past three years. CSC is currently considering making changes to program rules to manage costs going forward and new enrollments for non-emergency cases have been paused in the meantime. CSC will also amend the FY2026 Agreement to permit \$515K from the prior contract year increase to be rolled forward. See proposed Budget Amendment #3 in this Finance Committee packet and the proposed Agreement Amendment item in the Executive Committee packet for more information.

Background Information:

In June 2025, the Board approved a preliminary annual budget that reflected estimated revenues and expenditures pending receipt of the actual grant award letters from funders. In September, the Board approved Amendment #1 after the Division of Early Learning (DEL) issued final notices of award for FY26 in August. In November, the Board approved Amendment #2 with further updates to local funding and grants revenue. At mid-year, proposed Budget Amendment #3 reflects updated revenue and expenditure projections for VPK, Vulnerable Populations and Educator Bootcamp programs.

Current Status:

Key changes and updates included in FY26 Budget Amendment #3 are as follows:

- **\$1,000,000 Decrease to DEL VPK funding allocation for FY26:** We currently project a 3% surplus in VPK by the end of the fiscal year due to changes in the number of 4-year-olds in Broward County for the year. This reduction aligns with the participation rates predicted by the Office of Economic and Demographic Research (EDR) at the Early Learning Programs Estimating Conference that analyzes demographic data each year. DEL allocates funding for VPK according to actual need each year and the unused allocation will be issued to other Coalitions that are projecting shortfalls.
- **\$515,143 increase for CSC's Vulnerable Populations Program:** The Vulnerable Populations Program has been experiencing steady growth over the past several years. This sustained growth, combined with reduced School Readiness funding available for transfers and a substantial (50 percent) increase in the average cost of care per child over time, has placed the program at the upper limits of its available resources. After three consecutive years of supplementing the program with additional funds to accommodate increasing referral volume and pace, CSC has determined that a fresh look at eligibility criteria is necessary to realign referral guidelines for CSC-funded referring agencies with the program's original goals, vision, and available funding levels.

CSC and ELC staff are collaborating to develop revised program rules for long-term implementation. Meanwhile, CSC has authorized the following interim measures to balance 2026 contract-year enrollment with available funding:

- Amend the ELC's 2026 Agreement to add \$515,143 in unused funds from the 2025 Agreement to the 2026 budget.
- Pause all new non-emergency referrals to the program effective January 23, 2026, to reduce enrollment levels through natural attrition, transfers to School Readiness, and forthcoming program rule changes, as appropriate. CSC staff will work in coordination with ELC staff to make individual determinations regarding requests for emergency services during this referral pause. ELC staff will monitor expenditures and projected utilization and keep CSC staff apprised.
- **\$47,250 for Early Educator Bootcamp Stipends moved from unallocated:** In December 2025, PNC /AEJC awarded a \$22,750 professional development grant to Broward to support one of two planned Early Educator Bootcamps in 2026. \$20,250 of this grant will be allocated for participant and Provider stipends. The expected award, which was funneled from PNC to the Association of Early Learning Coalitions (AEJC) to a few selected ELCs, was previously budgeted in miscellaneous grant revenues and expenditures were in unallocated. We also propose moving an additional \$27,000 from our School Readiness base unallocated balance into stipends to support a second bootcamp during the 3rd or 4th Quarter of the year.

Background

Under specific appropriation in the Florida fiscal year 2025-2026 budget, all 31 Early Learning Coalitions throughout the state compete for funding from a \$30 million statewide School Readiness Program match pool. Awards are based on the documented match commitments received from local government or private funders from each early learning coalition. For FY26, Broward was awarded approximately \$5.9 million from this pool based on commitments from more than 20 County and Municipal funding sources.

The City of Fort Lauderdale has long served as the Early Learning Coalition's largest municipal contributor to the School Readiness Match program. It is home to more participating children than any other municipality, representing more than 3,200 (16%) of the more than 20,000 children served by the Coalition annually.

Current Status

On December 3, 2025, the City of Fort Lauderdale notified Coalition staff that a \$100,000 contract for continued match funding had been approved by the City of Fort Lauderdale Commission and that the Coalition Board Chair must sign and return the Agreement by the end of calendar year 2025. Since there were no Board meetings scheduled prior to the due date, staff initiated the review and signature process to meet the deadline and are presenting the Agreement for ratification by the Committee in the January/February 2026 Committee and Board meeting cycle. The Agreement has been approved as to form by legal counsel, the Chair has signed it, and the Agreement has been submitted to the City for full execution. The Agreement term runs from October 1, 2025, through September 30, 2026.

Background

The Children's Services Council (CSC) Vulnerable Populations Program funds childcare services for exceptionally vulnerable children, from birth to age five (not yet enrolled in kindergarten), throughout Broward County who are not otherwise eligible for the School Readiness program. Children served through the Vulnerable Populations Program are referred for immediate services by several CSC-funded family support and related programs. Families later determined to be eligible for School Readiness are transferred as expeditiously as possible in order to preserve program capacity for new referrals. The Agreement operates on the CSC fiscal year, from October 1 through September 30.

During the first three months of the 2026 contract year, Vulnerable Populations Program enrollment averaged more than 600 children per month. This reflects a significant recovery from the pandemic-era low of 241 children during the 2021–2022 contract years and exceeds the pre-pandemic 2020 average of 453 children by more than 35 percent.

This sustained growth, combined with reduced School Readiness funding available for transfers and a substantial (50 percent) increase in the average cost of care per child over time, has placed the program at the upper limits of its available resources. After three consecutive years of supplementing the program with additional funds to accommodate increasing referral volume and pace, CSC has determined that a fresh look at eligibility criteria is necessary to realign referral guidelines for CSC-funded referring agencies with the program's original goals, vision, and available funding levels.

Current Status

CSC and Early Learning Coalition (ELC) staff are collaborating to develop revised program rules for long-term implementation. Meanwhile, CSC has authorized the following interim measures to balance 2026 contract-year enrollment with available funding:

- Amend the ELC's 2026 Agreement to add \$515,143 in unused funds from the 2025 Agreement to the 2026 budget.
- Pause all new non-emergency referrals to the program effective January 23, 2026, to reduce enrollment levels through natural attrition, transfers to School Readiness, and forthcoming program rule changes, as appropriate. CSC staff will work in coordination with ELC staff to make individual determinations regarding requests for emergency services during this referral pause. ELC staff will monitor expenditures and projected utilization and keep CSC staff apprised.

The draft amendment is under development by CSC staff and is pending legal review by ELC Counsel.
