# CEO Report Board Meeting – May 9, 2022

#### Welcome Ancel Pratt III – Senior Director of Communications & Outreach

Last week the ELC welcomed Ancel Pratt to the ELC team. He comes to us from EmGage, a statewide advocacy and civic engagement agency, where he served as CEO. Prior to EmGage, Ancel worked for both the Miami Heat and the Dwayne Wade Foundation. He comes with a rich communications background, and we look forward to his helping us broaden and deepen communications and community relationships.

### **School Readiness and VPK Enrollment Updates**

We are happy to announce that on April 13<sup>th</sup> we reduced lag time between applying for School Readiness and pull date to one day, effectively eliminating the waitlist for families with young children. While we are still processing a large volume of children from former waitlist pulls, we can confidently say our waitlist is now a processing list.

VPK applications for the 2022/2023 school year began in January and staff continues to process applications. We have also launched an outreach effort that includes social media, print advertising, direct emails, fliers to community partner organizations, and a new grass roots awareness campaign. Between our outreach campaign and decrease in Covid-19 cases, we believe VPK application/enrollment numbers will continue to increase for the FY 22/23 VPK year. To date, 8,197 applications are now approved for next school year.

#### The American Recovery Plan (ARP):

As previously reported, the Division of Early Learning (DEL) opened its American Recovery Plan (ARP) grant applications February 28<sup>th</sup>. The ARP award amount for ELC Broward is \$62.9 million (of which \$59,864,965 is for provider grants) for the first round of grants, with additional ARP funding awards expected thereafter over the next seven quarters. Individual provider grant amounts range from \$12,000 to more than \$360,000. Per DEL directive, approved grants will be paid in three equal quarterly installments.

Broward leads the State in the number of applications approved and installments paid. As of May 5, 2022, ELC staff had approved a total of 478 ARP provider grant applications totaling more than \$35.5 million in grant awards with first installments paid totaling more than \$11.5M. Approved awards will be paid in three installments issued in 90 day intervals.

#### **Broward Above and Beyond**

Broward Above and Beyond (BAAB), part of ELC Broward's child care workforce initiative, has now approved 48 child care providers to be part of the initiative. BAAB's kick-off orientation was held last week, with 32 child care directors/staff in attendance. A make-up orientation will be held next week for those directors who could not attend the first one. Coaching staff has already begun their visits to each of the centers. We are very excited at this opportunity to help onboard, upskill, and retain the child care educator workforce, and look forward to updating you as to our progress.

#### **Broward Bookworms**

We are busily promoting Broward Bookworms. It is prominently featured in the current edition of Family Life Magazine, has been promoted through social media and radio ads, and has been distributed through our partner agencies. We have had requests for more than 4,500 book packets to date, and we expect that number to grow as we conduct outreach through other media opportunities, and through other local partners, like Museum of Discovery and Science (MODS). MODS has offered to allot space for a book nook and sign-up station for any family visiting the Museum.

### Strategic Planning (SP) Process and Retreat

Over the past few months ELC Senior Leadership, the Ad Hoc Committee, and Carol Wick, our SP consultant, have continued to meet. Carol has conducted one on one meetings with 50% of the board and has surveyed the full Board for feedback which will be utilized in the strategic planning process and Board retreat. Based on the updated timeline for the SP, a new date for the Board Retreat will be May 17<sup>th</sup>, which will take place in person only at the ELC office. At the retreat the Board will be presented with the work that has been completed by ELC staff and the Ad Hoc Strategic Planning Committee by that point. Members will then discuss ELC's future and establish a consensus on the direction of the organization moving forward based on the information presented.

#### **Board Private Provider Representative**

Applicants have been received and reviewed by ELC staff to ensure candidates meet the criteria. Following the review process there are four remaining candidates. They have all been informed of the process and are aware that the Nominating Committee will be meeting on May 26<sup>th</sup> 2022 at 9:00am and that they will have an opportunity to speak with the Committee at that time. The names and centers they represent has been posted on our website and a Constant Contact communication has been sent to all ELC providers asking them to provide any/all feedback on the candidates by COB May 13, 2022. This information along with the applications and references will be presented to the Nominating Committee members in advance of the meeting.

### **Provider Appreciation Event**

We are excited to announce ELC Broward has invited all Broward child care providers to celebrate National Provider Appreciation Day. Our celebration will take place at 6:30-8 pm at our office. The theme is "M&M's- Thank You for Being Marvelous and Magnificent." A light dinner will be served, along with M&M's! We have received more than 80 RSVP's to date. All board members are also welcome to attend!

#### **Countdown to Kindergarten Event**

On April 30<sup>th</sup>, hundreds of families and a handful of pigs attended Broward's Countdown to Kindergarten event, held at Parker Playhouse. This was the first Countdown to Kindergarten event since the start of the pandemic, and it was very well attended. Families were treated to a mini-play about the healthy adventures of the three pigs, and were cheer led about Kindergarten by leaders of the ELC, CSC, School District, and Broward County government. More than 20 vendors, including the ELC's Broward Above and Beyond Team, were on hand to engage attendees in activities with the children and hand out informational materials. Children (and adults) were also treated to a mini-pig petting zoo!

#### **ELC Board Officer Positions**

As discussed at the April Board Meeting, the current slate of ELC Board Officer positions term out on June 30, 2022. Additionally, the Board approved to update the Officer term policy recommended by the Governance Committee that will align the term policy of Officer positions with those of the Committee Chairs, allowing Officers to serve two consecutive terms. Previously the policy did not allow for Officers to serve two consecutive terms. The next steps in the process are that the list of nominations goes to the Nominating Committee which is scheduled for May 26, 2022. The Nominating Committee will then review the candidates and make recommendations to the Board at the June meeting.





Billing Group	BG	An eligibility category that aligns with Chapter 411, Florida Statutes, which describes the different groups or defined categories of children served; a category of direct service costs. The following defines the various billing groups:  **BG1 - At Risk Populations:** School readiness services for a child in a family that is: referred for investigation by the Broward Sheriff's Office (BSO); under the supervision of ChildNet (in home, foster care or relative/no relative placement); in the custody of a parent who is homeless, as verified in law; in the custody of a parent who is the victim of domestic violence, residing in a certified DCF shelter or; actively participating in a diversion program as required by law.  **BG3 - Temporary Assistance for Needy Families (TANF), also referred to as Temporary Cash Assistance (TCA)  **Families who are receiving TCA, and subject to the federal work requirements.  **BG3R - Relative Caregiver**  Child who is in receipt of the Relative Caregiver (RCG) payment, who is adjudicated by a Florida court and placed in the home of a relative through ChildNet.  **BG5 - Transitional Child Care (TCC)**  Family that is transitioning from the receipt of TCA (from a workforce program) into employment, as defined by law.  **BG8 - Income Eligible**  Family that is economically disadvantaged. Parent must meet income and work requirements, which include employment, educational activities or disability.  **CSC - Children's Services Council Vulnerable Populations Program**  Eligibility mirrors the Income Eligible (BG8) criteria. Other conditions may be set by CSC, on an as needed (case-by-case) basis.

The federal Child Care and Development Fund (CCDF) is an aggregate of several funding sources that is distributed in block grants by the federal government to the states and territories. The majority of the funds are to be used to provide child care services to families who meet certain income and need criteria. A portion of the funding (at least 4 percent of the block grant amount) is to be used for activities to improve the quality of child care. Another portion (not to exceed 5 percent of the block grant amount) is to be used to pay for costs of administering the CCDF. The purpose of the CCDF is to increase the availability, affordability, and quality of child care services.  Every two years, states and territories receiving CCDF funds must prepare and submit to the federal

The purpose of the program is to ensure a healthy and safe environment for the children in child care settings and to improve the quality of their care through regulation and consultation. Child Care Resource and Referral Program	CCR&R	The Child Care Resource and Referral Network is dedicated to helping families find answers to their questions regarding how to identify quality child care and early education programs. The CCR&R program also conducts a search for providers that meet the specific needs of the family; the CCR&R program also provides information and community resources that may benefit the entire family.
Children's Services Council	CSC	A Children's Services Council is a local government body that oversees funding for programs and services that improve the lives of children and their families. Chapter 125 of Florida Statutes governs the creation and operation of a Children's Services Council, commonly referred to as a CSC. Florida is the only state in the nation that empowers communities to create a local government with the sole purpose of investing in the well-being of families.
Child Development Associate	CDA	A nationally recognized early childhood professional credential awarded to individuals who successfully complete the nationally established requirements of the CDA program to work with young children.
Classroom Assessment Scoring System™	CLASS	The Classroom Assessment Scoring System™ (CLASS™) is an observational tool that provides a common lens and language focused on classroom interactions that boost student learning. This tool is used as the basis for the State of Florida's Quality Rating System, and CLASS scores are used to calculate payment differentials for child care facilities serving subsidized children.
Continuing Education Units	CEUs	A measure used to track continuing education; in general, a CEU is defined as 10 clock hours of participation in a recognized continuing education program with qualified instruction and sponsorship through an accrediting CEU body.
Enhanced Field System Modernization	EFS Mod	The billing system currently in use for early learning programs.
Environment Rating Scales	ERS	The Early Childhood Environment Rating Scales are designed to assess process quality in an early childhood or school age care group. Process quality consists of the various interactions that go on in a classroom between staff and children, staff, parents, and other adults, among the children themselves, and the interactions children have with the many materials and activities in the environment, as well as those features, such as space, schedule and materials that support these interactions. Process quality is assessed primarily through observation and has been found to be more predictive of child outcomes than structural indicators such as staff to child ratio, group size, cost of care, and even type of care, for example child care center or family child care home (Whitebook, Howes & Phillips, 1995). Florida Sunshine Law		The "Sunshine Amendment," adopted by Florida voters through a constitutional initiative in 1976 as Article II, Section 8, Florida Constitution, contains standards of ethical conduct and disclosures applicable to public officers and employees; it also requires the Legislature to adopt the code of ethics (see Code of Ethics definition above).
Gold Seal		In 1996, the Florida Legislature established the Gold Seal Quality Care program to acknowledge child care facilities and family day care homes that are accredited by nationally recognized agencies and whose standards reflect quality in the level of care and supervision provided to children. The QRIS system also uses CLASS scores to reimburse child care providers on a scale. Child care providers with higher CLASS scores receive higher reimbursement rates.
Registered Family Child Care Provider		An individual that provides child care for fewer than 24 hours a day per child, as sole caregiver, in a private residence other than the child's home and meets the state and/or local registered family child care requirements.
Religious Exemption		A child care facility which is an integral part of church or parochial schools conducting regularly scheduled classes, courses of study, or educational programs accredited by, or by a member of, an organization which publishes and requires compliance with its standards for health, safety, and sanitation. Such facilities shall meet minimum requirements of the applicable local governing body as to health, sanitation, and safety and shall meet the screening requirements pursuant to ss. 402.305 and 402.3055. Failure by a facility to comply with such screening requirements shall result in the loss of the facility's exemption from licensure.
School-Age Child Care Provider		A provider licensed or authorized as license-exempt to provide care and education of children who are at least 5 years of age by Sept 1 of the beginning of the school year and who attends kindergarten through grade 5.
School Readiness Program		The School Readiness Act, Chapter 411.01 of the Florida Statutes, School readiness programs are to be full-day, year-round to the maximum extent possible, to enable parents to work and become financially self-sufficient.
Teacher Education and Compensation Helps	T.E.A.C.H.	A scholarship program, which provides educational scholarships and financial incentives to caregivers and administrators of early childhood programs, family day care homes, and large family child care homes.
Temporary Assistance for Needy Families	TANF	Temporary Assistance for Needy Families (TANF) is one of the federal assistance programs. It began on July 1, 1997, and succeeded the Aid to Families with Dependent Children (AFDC) program, providing cash assistance to indigent American families with dependent children. This cash benefit is often referred to simply as "welfare." TANF was created by the Personal Responsibility and Work Opportunity Act instituted in 1996. The Act provides temporary financial assistance while aiming to get people off of that assistance, primarily through employment. The reform granted states wide discretion of how to distribute TANF entitlements.

Voluntary Prekindergarten Program	VPK	A constitutional amendment passed by Florida's voters in Nov. 2002, required a voluntary prekindergarten program for all four-year-old children. VPK is a program designed to prepare four-year-olds for kindergarten and build the foundation for their educational success. The program allows a parent to enroll his or her eligible child (four years old by September 1 and residing in Florida) in a free VPK program. The program is voluntary for children and providers.
Wait List		"Waiting list" means a list of children waiting for potential enrollment in the school readiness program once funding is available. The list is a record of the names of parent(s), the names and dates of birth of their children, waiting list date and anticipated eligibility and priority category for seeking school readiness services.
