All were in favor.  Renee explained that the reason for item D was that a draft amendment was still pending from DCF.  There was a Motion to approve the Consent Agenda by Ellie Schrot and Seconded by Twan Russell. Motion Passes.  Chair, Laurie Sallarulo asked if we needed to get a match for the funding from the cities.  The requirement for ELC's to collect the match and the way in which the state is distributing match funding has changed. OEL is not requiring ELC to raise a 6% match as this federal requirement is already satisfied through the state's VPK funding. In order to now receive School Readiness match, we have to demonstrate commitment of local funding to OEL. Based on this local amount raised, OEL will allocate up to a dollar for dollar match to the Coalition.  Twan had a question regarding page 16 in the Finance packet regarding the fiscal year. The report is for the money we raised last year. We are in the process of getting all proposals together for FY 19-20.  Chair, Laurie Sallarulo mentioned that it would be great to bring a Board member to go to a donor/commissioner meeting. ELC is formalizing the schedule and will forward to Board members. This would be a great way to get the Board more engaged.  A Motion was made by Ellie Schrot to adjourn the Executive Committee Meeting.
