OFFICIAL RAFFLE RULES

1. Eligibility

The Early Learning Coalition of Broward County, Inc. and Broward Workshop, Inc. are raffling off fifteen (15) \$100 Amazon gift cards (the “Raffle”). The following persons are eligible participants (“Participants”):

Participants must be at least eighteen (18) years old and meet one of the following criteria:

1. A parent of a child aged birth to kindergarten who completes the parent survey or kindergarten parent survey;
2. A Broward childcare provider caring for children birth to five who completes a childcare provider survey; or
3. A Broward early educator currently employed at and working in a classroom of a childcare program with children birth to five enrolled.

All Participants will be required to comply with all Official Rules of the Raffle.

Employees, agents, officials, or board members of Early Learning Coalition and Broward Workshop are not eligible, to include each of their immediate family members (i.e. parent, spouse, child, or sibling). The Raffle is subject to all applicable federal, state and local laws and regulations.

2. Sponsor

The Raffle is sponsored by the Early Learning Coalition of Broward County, Inc. (“Early Learning Coalition” or “ELC”), located at 1475 W. Cypress Creek Road, #301, Fort Lauderdale, FL 33309 and the Broward Workshop, located at 150 SE 2nd Avenue, #200, Fort Lauderdale, FL 33316. The funds necessary to conduct this raffle will be derived from a grant from the Broward Workshop to ELC.

3. Agreement to Official Rules

Participation in the Raffle or receipt of the prize shall constitute full and unconditional agreement to and acceptance of the Official Rules and all decisions of the Sponsor, shall be final and binding. Receipt of any prize won is contingent upon compliance with these Official Rules and fulfilling all other requirements set forth herein.

4. Raffle Period

The Raffle begins on May 1, 2026 at 11:00 A.M. EST and concludes on June 6, 2026 at 4:59 P.M. EST (the “Raffle Period”). Entries that are submitted will be accepted online and by mail as indicated for the duration of the Raffle period.

5. How to Enter

NO PURCHASE OR CONTRIBUTION IS NECESSARY.

Entry will be available by visiting the Raffle website at https://elcbroward.org/elc_raffle and following the directions on the website. Following completion of the survey and the survey participant demographic information raffle entry, Participants will receive a confirmation email of their Raffle Entry.

Alternate Entry: In order to receive a raffle ticket without completing the ELC Survey, you must visit https://elcbroward.org/elc_raffle to complete the Ticket Without Purchase Form. The Ticket Without Purchase Form must be received by mail or delivered to ELC's offices at 1475 W. Cypress Creek Road, #301, Fort Lauderdale, FL 33309 no later than June 6, 2026 at 4:59 P.M. EST.

Each person may only receive one (1) Raffle Ticket whether provided upon receipt of their Ticket Without Purchase Form or Survey submission.

For all Raffle Ticket requests, an acknowledgment will be electronically mailed to the e-mail address provided by the Participant. The Sponsor will not mail paper Raffle Tickets; a valid e-mail address is required for all Participants.

6. Prize Drawing

On June 12, 2026 at 11:30 A.M. EST, the Sponsor will select the winners in a random drawing from among all eligible entries received. The winner is not required to be present to win.

7. Winner Notification

The ELC will notify all eligible winners of the Raffle within five (5) business days of the Drawing. Notifications to winners will be delivered via e-mail only, using the e-mail address set forth on the Raffle Ticket entry. The prizes identified below (collectively the "Prizes"; each a "Prize") will be awarded on a first drawn, first choice basis. Following initial notification of all winners, winners will have two (2) weeks from such e-mailed notice to claim a Prize by replying to the email and confirming their mailing address. If the winning Raffle Ticket holder does not claim their Prize, within this two (2) week period, such Raffle Ticket holder will be deemed to have forfeited their Prize. The Sponsor may then select an alternate winner in their place at random from the remaining eligible entries. The winners will have the Prize mailed to them at the address provided to ELC.

8. Prize

Fifteen (15) Amazon Gift Cards in the amount of \$100.00 each will be awarded to each of the Fifteen (15) Prize winners.

9. General Conditions

In the event that the operation, security, or administration of the Raffle is impaired in any way or for any reason, including but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the event the Raffle is unable to run as planned for any other reason, as determined by the Sponsor in its sole discretion, at the Sponsor's sole option it may, either (a) suspend the Contest to address the impairment and then resume the Raffle in a manner that best confirms to the spirit of the Official Rules; or (b) terminate the Raffle and, in the event of termination, award the prize at random from among the eligible, non-suspect entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to have tampered with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Raffle may be a violation of criminal and civil law, and should such an attempt be made, the Sponsor will make the necessary referrals to the appropriate law enforcement agencies and also reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision. By submitting or providing any telephone number, e-mail address, or other contact information in this Raffle, you expressly give consent to be contacted by the Early Learning Coalition using all such contact information. By entering the Raffle, Participants agree that their names, likenesses and/or information provided in connection with the Raffle entry may be used for the benefit of the Early Learning Coalition and Broward Workshop, including, but not limited to, being disclosed to and used for publicity purposes in newspapers or other media, including print venues, television, radio, social media, or online (including the website of the ELC or Broward Workshop).

10. Release and Limitations of Liability

By participating in the Raffle, Participants agree to release and hold harmless the Sponsor, its agents, partners, affiliates, advertising and promotion agencies, other companies associated with the Raffle, and each of their respective officers, directors, employees, representatives and agents (the Released Parties) from and against any claim or cause of action arising out of participation in the Raffle or receipt or use of the prize. The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by Participants, printing errors or by any of the equipment or programming associated with or utilized in the Raffle; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Raffle; (4) technical or human error which may occur in the administration of the Raffle or the processing of entries; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from Participants' participation in the Raffle or receipt or use or misuse of any Prize. If for any reason a Participant's entry is confirmed to have been erroneously deleted, lost or otherwise destroyed or corrupted, Participant's sole remedy is another entry in the Raffle, provided that, if it is not possible to award another entry due to discontinuance of the Raffle, or any part of it, for any reason, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. No

more than the stated number of prizes will be awarded. Sponsor is not responsible for typographical or other errors in the offer or administration of this contest, including but not limited to errors in advertising, the Official Rules, the selection and announcement of winner or the distribution of any prize. All entries become the property of Sponsor and will not be acknowledged or returned.

11. Venue, Construction, and Sponsor Policies

Venue: Except where prohibited, each Participant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Raffle or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court with jurisdiction in Broward County, Florida.

Construction: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of any Participant and Sponsor, shall be governed by, and construed in accordance with the laws of the state of Florida, without giving effect to any choice of law or conflict of law rules or provisions. The invalidity or unenforceability of any provision of these rules shall not affect the invalidity or unenforceability of any other provision. In the event that any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.

Florida has a very broad Public Records laws.
